Note: What you get, What is expected, Policies, Regulations and Orari Equestrian Centre (OEC) Conditions may be changed or altered at any time during your membership.

### **What you get for your subscriptions?**

- Members have access to parts of the Orari Equestrian Centre and its facilities, including the Arena (special conditions apply– see below). No form of business may be conducted on the OEC property without prior approval by the OEC. Any members wishing to use the OEC grounds/arena for **ANY** purpose that involves payment, including, but not limited to: instruction, saddle fitting, dentistry work, clinics, etc, need to contact the AWRC Secretary (awrcsecretary@gmail.com) who will liaise with the OEC for rates, obligations and approval.
- Monthly Club Day, this will be held on the first Sunday of each month at Orari Equestrian Centre (special conditions apply as at times other bookings may take precedence, i.e. the Races, trials, etc)
- Any other club days, treks, training etc., organised by the club and its members.

### **What is expected of members?**

- Help on club days or events
- Attend meetings when possible
- Read the Constitution (available online)
- Abide by the AWRC Constitution and be aware about consequences:  
4.5.2 (i) willfully disobeyed any of the rules of the club or (ii) i acted in a way which is derogatory to the character or prejudicial to the interests and objects of the Club, may be suspended, expelled or censured by a two-thirds majority of Executive Members present and voting at an Executive Committee Meeting of the Club. Any disciplinary action shall be taken in accordance with the disciplinary policies of the Club.

### **Rules for use of the OEC grounds/Arena / Special Conditions (Orari Equestrian Centre):**

*The following are the Orari Equestrian Centre Rules of the Grounds which both the Aoraki Western Riding Club and Geraldine Pony Club have accepted as Ground Users (note these may changed or altered at any time):*

1. All gates must be shut and secured after entering and re-padlocked on exiting. Please check that you have actually locked the padlock when leaving.
2. Padlock code is confidential to your membership.
3. No equipment, poles and jumps belonging to the pony club are to be used unless prior arrangement as be obtained from the Geraldine Pony Club. If approved all equipment must be returned to its place of residence.
4. All damage must be reported to the secretary (awrcsecretary@gmail.com) immediately or if you notice any damage to the grounds or equipment please can you also let the president know.
5. Membership Cards should be held and be accessible to be viewed while the grounds are being used.
6. No dogs are permitted on the grounds
7. Floats must enter at signposted gates (west of the grounds)
8. Anyone using the grounds must either be a current financial member of the Aoraki Western Riding Club or the Geraldine Pony Club.
9. Accidents and notifiable hazards must be reported to the AWRC secretary (awrcsecretary@gmail.com) as soon as practicable.
10. The grounds must be left in a clean and tidy state before leaving. You are responsible for picking up your own horses manure from both the grounds and the arena and taking it home with you as well as any rubbish.
11. The barrow provided is for the arena only when an event is being held.
12. No horses are to be tethered to the arena fence
13. No horses are to be left unattended or loose in the arena or outside of the arena
14. You must sign the register and provide the requested details when you use the grounds and or arena.  
(The book can be found attached to the outside of the clubhouse in a plastic holder)
